

## 19 - POLICY CONCERNING NOTICES OF NIGHT DEPARTURE FOR VOYAGES IN DISTRICT NO.2

## 1. Objectives of the Policy

The objective of this Policy is to set out notice requirements for nighttime departures for ships in District No. 2. The notice requirements set out in this Policy do not apply to situations related to navigational emergencies or movages within the Port of Québec.

# 2. Background

Based on the results of a risk assessment and recommendations related to pilot fatigue and sleep management, the departure notice requirements set out in herein are coming into effect on January 16, 2023, 15:00 in District No.2.

## 3. Policy statements and requirements

- 3.1 Any pilotage service requests for:
  - From a ship originating from a secondary port in District No. 2 or from one of its anchorages must be confirmed with the LPA Dispatch Centre **before 15:00** for any scheduled departure between 21:00 and 08:30 (L.T.), while respecting the requirement of at least 12 hours' notice before the planned departure time;
  - A ship planning to pass at the Escoumins Pilotage Station between 21:00 and 08:30 (L.T.) must inform the LPA Dispatch Centre **before 15:00** while respecting the requirement of at least 12 hours' notice before the planned departure time;
- Any pilotage service requests from a ship originating from the Port of Québec in District No. 2 or one of its anchorages must be confirmed with the LPA Dispatch Centre **before 15:00** for any departure between 19:00 and 05:00 (L.T.), while respecting the requirement of at least 12 hours' notice before the planned departure time;
- 3.3 Only one notice per ship will be authorized;
- 3.4 The ship's confirmed departure time from a wharf or anchorage in Quebec City may be delayed only once, by a maximum of 2 hours, provided the change is reported to the LPA Dispatch Centre at least 4 hours before. From a wharf or anchorage from a secondary port, the change must be communicated at least 6 hours prior to the confirmed departure time.
